What is the aim?

The overall objective of Europe's New Training Initiative for Civilian Crisis Management (ENTRi) is to improve the human security (Freedom from Fear) of people living in crisis-prone areas to which crisis management and stabilisation-type missions ("crisis management missions") of the EU, the UN, the OSCE, the AU and/or other organisations are deployed. The project aims at better enabling staff in those missions to work in an efficient, effective and sustainable manner in order to achieve their missions' mandates.

What do we deliver?

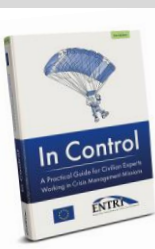
- ENTRi currently offers the following courses: **Rule of Law** (Stadtschlaining, Austria 05-09 February 2018) and **Human Rights** (Addis Ababa, Ethiopia 08-16 February 2018). Courses cover theory and practice to align specific course content with regional contexts, they are free of charge, but participants are required to cover their own travel costs. - ENTRi III divided its tasks among five working groups (WG): **Certification, Evaluation, Training of Trainers, E-Learning** and **Course Package Development (CPD)**. The WG Certification aims to ensure the promotion of European training standards by processing C³MC certifications of course content/methodology that has been checked by ENTRi partners. The WG Evaluation evaluates ENTRi activities, using common tools to create comparable data and to close the loop between lessons learnt and creation of new ENTRi material/products. The WG Training of Trainers (ToT) is developing a didactical toolkit for crisis management courses and implement six ToT courses worldwide. The WG E-Learning is developing technology-enabled learning products. The WG CDP will produce nine "off-the-shelf" packages of training courses/modules that can be flexibly used by crisis management missions and trainers.
- ENTRi works to cooperate with the planning and operational bodies of international organisations to share and further develop training standards and identify needs, as well as improve coordination with staff-contributing countries.
- ENTRi III and the EU Police Services Training Consortium (EUPST II) cooperate closely and are planning joint activities, also on the African continent.

Context and background

ENTRi is an initiative funded by the European Commission (90%) and co-funded by its 12 implementing partners under the lead of the Center for International Peace Operations (ZIF) in Berlin. It began in 2011 and is set to run until May 2019. The total budget of the programme since its inception is roughly 8 million Euro. The implementing partners come from different Member States of the European Union and Switzerland. ENTRi was created by the European Union's Instrument contributing to Stability and Peace and is guided by the European Commission's Service for Foreign Policy Instruments (FPI), which is co-located with the European External Action Service. The ENTRi partners are: Austrian Study Centre for Peace and Conflict Resolution (ASPR); Diplomatic Institute (BDI), Bulgaria; Centre for European Perspective (CEP), Slovenia; Crisis Management Centre Finland (CMC); École Nationale d'Administration (ENA), France; Royal Institute for International Relations (Egmont), Belgium; Folke Bernadotte Academy (FBA), Sweden; Netherlands Institute of International Relations Clingendael (NIIB); Stabilisation Unit (SU), United Kingdom; Swiss Expert Pool for Civilian Peace Building (SEP); Sant'Anna School of Advanced Studies (SSSUP), Italy; and the Center for International Peace Operations (ZIF), Germany. The Organization for Security and Co-operation in Europe (OSCE) and the United Nations Department of Peacekeeping Operations (UN-DPKO) are associate partners.
